

**Michigan Shorthorn Breeders Association**  
**Annual Meeting Minutes**  
**Sunday, October 13, 2024, Copper Athletic Club, Marshall, MI**

The 2024 annual meeting of the Michigan Shorthorn Breeders Association was called to order at 1:35 p.m. by President, Stacy Stinson. We had 17 people in attendance. Prior to calling the meeting to order, we enjoyed a delicious meal provided by Copper Athletic Club. Member and guest introductions were made. Sydney Miller moved to accept the agenda; Megan Bossard supported the motion. The motion passed.

Our guest speakers were Kenna Geeseman and Megan Noack.

As the National Shorthorn Lassie Queen, Kenna shared highlights of her experiences over the last year. She has had a tremendous opportunity and has met many wonderful people. A new Lassie queen will be crowned at the 2025 Cattleman's Congress in Oklahoma City, OK in January.

Megan Noack is the Global Product Marketing manager for Neogen Corporation. Her primary responsibilities include natural toxins in livestock feed. She shared information on the different toxins that can show up in livestock feed and the acceptable levels of those toxins for various species of livestock. She is a great resource to ensure producers are aware of these toxins and how to feed accordingly.
